1. AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you") and Smart eye biz private limited ("Company," "we," "us," or "our"), concerning your access to and use of the _____ website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the "Site"). We are registered in Pakistan and have our registered office at _____, Lahore. You agree that by accessing the Site, you have read, understood, and agreed to be bound by all of these Terms of Use.
